



# PERSONAL DATA PROTECTION AND PRIVACY STATEMENT

## SECTION 1: INTRODUCTION

This statement outlines the general principles of MAHSA International College's policy regarding the collection and processing of your personal data.

MAHSA International College is committed to safeguarding your personal data and ensuring full compliance with Malaysia's personal data protection laws and regulations.

## SECTION 2: CONSENT

## SECTION 3: NOTICE AND CHOICE PRINCIPLE STATEMENT

## **SECTION 4: PURPOSE OF DATA PROCESSING**

Your personal data may be used by authorized personnel of MAHSA International College for purposes including (but not limited to):

- Processing applications for pre-College, undergraduate, and postgraduate studies
- Updating records and informing you of available courses or programmes
- Communicating with you and/or your parents or guardians
- Adding you to the MAHSA International College alumni database
- Sending course brochures, promotional materials, and updates
- Managing and tracking payments
- Research, reporting, and statistical analysis
- Employment consideration (if applicable)
- Other lawful College-related activities
- Compliance with legal or regulatory obligations, including disclosures mandated by law or court order

## **SECTION 5: DISCLOSURE TO THIRD PARTIES**

Your personal data may be shared, when necessary, with the following third parties:

- Financial institutions for payment processing
- Third-party service providers engaged by MAHSA International College
- Government or regulatory authorities
- Legal advisors, insurers, auditors, consultants, or professional advisors
- Members of the Board of Directors, Board of Governors, or shareholders
- Entities to whom MAHSA is legally required to disclose information
- Regulatory agencies or authorities under applicable laws or court orders

## **SECTION 6: PROCESSING SCOPE**

Your personal data will be processed strictly for the purposes described above.

## **SECTION 7: CONSEQUENCES OF WITHHOLDING DATA**

Failure to provide your personal data may result in:

- Inability to process your application for admission

- Inability to inform you of developments or changes within the College

## **SECTION 8: RIGHT TO ACCESS AND CORRECT DATA**

You have the right to request access to your personal data and to make corrections to ensure its accuracy. You may also choose to limit how your data is processed. Such requests must be submitted in writing to the Registrar's Office (see Section 12 for contact details).

## **SECTION 9: INQUIRIES OR COMPLAINTS**

Any inquiries or complaints about the use of your personal data should also be directed to the Registrar's Office.

## **SECTION 10: DATA SECURITY**

MAHSA International College has implemented appropriate security measures and policies to protect your personal data in line with applicable data protection laws. Where processing is performed by a third party on behalf of MAHSA International College, we require such parties to maintain data security in accordance with our standards.
